IMPORTANT: Membership forms received in the mail, at the above address, by February 20, 2005 will be processed, **LAMINATED**, and cards will be mailed back in time for Districts. Please do not mail in membership forms after February 20th, but purchase your membership at the District Tournament you attend. Each District will have a listing of wrestlers who have paid in case cards are forgotten or misplaced. Memberships are available at all Districts for \$12.00*. Extra \$2.00 will go to the club hosting the District Tournament. The card you receive at the District is your card for the year.

SECONDARY INSURANCE: Secondary Insurance covers a wrestler up to \$25,000 with a \$250.00 deductible from American Sentinel Insurance Company. Secondary Insurance is included in the Membership Fee. Insurance coverage for 2005-06 season runs from 9/1/05 through 8/31/06. Wrestlers who purchased cards for the 2004-2005 season are no longer under coverage. To renew coverage, please be sure to purchase a Membership Card before you begin wrestling. Wrestlers are covered during practice, NYWA tournaments and all other tournaments they attend during the season.
